<p>How supplied and physical characteristics</p> 	<p>ONPATTRO is supplied as a 10 mg/5 mL (2 mg/mL) solution in a single-dose glass vial.<sup>1</sup></p> <p>ONPATTRO is a sterile, preservative-free, white to off-white, opalescent, homogeneous solution for intravenous infusion. The vial stopper is not made with natural rubber latex. ONPATTRO is available in cartons containing one single-dose vial each.<sup>1</sup></p>								
<p>Vial storage and handling</p>	<p>Store at 2°C to 8°C (36°F to 46°F). Do not freeze. Discard vial if it has been frozen. If refrigeration is not available, ONPATTRO can be stored at room temperature up to 25°C (77°F) for up to 14 days.<sup>1</sup></p>
